

## EAST COAST HAVANESE CANINE CONTRACT

This is a 2-page contract for the sale of a Purebred Havanese.

This document concerns a live animal and is executed in favor of that animal's well being by those signing. The buyer agrees to all terms and conditions set forth below:

Buyer will be given the AKC **LIMITED** Registration papers and can register the puppy under their name. Buyer will also receive a vet health record for the puppy including deworming and at least the first in the series of puppy shots.

Buyer to have the puppy vet-checked within 5 days. Breeder will take the puppy back within the five days if there are any vet documented health issues and refund the purchase price to the buyer.

This puppy is considered a family dog and is to be kept indoors and never to be left outside. Buyer is to provide all maintenance including a healthy diet, groomed regularly and yearly veterinary checkup and vaccines.

Buyer warrants that this puppy is being purchased solely as a pet and will remain in the buyer's custody. **If, for any reason, the buyer cannot keep this dog it must be returned to the breeder who will find it a new home.** Any monies received through placement of the dog shall go to the prior owner, minus any vet costs and expenses.

Page 2 East Coast Havanese Contract

The puppy must be spayed/neutered before the age of 7 months and proof provided to breeder. If buyers fail to spay/neuter the puppy by 7 months, the breeders will take the puppy to their vet to be spayed/neutered and return it when vet costs and expenses have been paid by the buyer.

This dog will **NEVER** be used for breeding purposes. If it is, the breeder has the right to take the dog back from the buyer immediately and has the right to any puppies resulting from the breeding. The breeder also has the right to seek financial retribution, including but not limited to any monies gained from said breeding.

Breeder provides a 2 year guarantee of health for life-threatening, hereditary diseases and will replace, or refund up to the purchase price of the puppy. Any health problems must be documented by a veterinarian and the buyer needs to provide a copy of the dog's vet record showing a complete history of timely and up-to-date veterinary care and vaccinations. The buyer is responsible for all costs in returning the dog to the breeder.

By signing this document the buyers agree to all the terms listed above.
